## INTRODUCTION

To the Lot Owners:

The Trustees observe with pleasure a growing desire on the part of the lot owners to preserve and increase the beauty of their lots, and in reply to the numerous inquiries, submit the following general suggestion for the care and improvement of lots:

It is the aim of the Trustees to make Evergreen Cemetery and Memorial Gardens quiet, beautiful resting places for the dead, where well-kept turf and varied foliage of trees and shrubbery shall give a sense of repose.

---

## LOT PURCHASES

Section 1. Persons desiring to purchase lots should visit the office of the Cemeteries, where the Executive Director and Superintendent will aid them in making a selection. Payment for same will be made to the Executive Director in the office of the Cemetery Association.

Section 2. Conveyances of a lot or lots will be made by the Association to one person, only.

Section 3. It is the duty of the Lot Owners to notify the Executive Director of the Association of any changes in their address.

Section 4. Notice sent to a lot owner at the last known address on file with the Association shall be sufficient and proper notice.

Section 5. Purchases in the Garden of Paradise at Memorial Gardens must be for a minimum of ½ of a lot to allow for erection of a monument.

---

## PERPETUAL CARE

Section 1. Perpetual care is mandatory with the purchase of lots.

Section 2. Perpetual care includes cutting, raking and watering of lots from May 1st to October 1st of each year as well as maintaining the lot at the established level. Perpetual Care does not include the watering of trees, shrubs nor plants in urns or containers.

- b. They shall only be driven on the roadways.
- c. The days and hours of operation in the cemeteries are as noted in Section 1.
- d. All vehicles shall be equipped with appropriate mufflers so as to reduce noise to a minimum.

Section 4. Children up to the age of 15 years not accompanied by a parent or guardian will not be admitted.

Section 5. All persons are prohibited from picking any flowers or injuring any tree plant or shrub, or marring or defacing any monument of stone or any structure within the cemeteries.

Section 6. No person shall have in his or her possession a firearm or explosive, excepting an on-duty police officer and member of military organizations (e.g. National Guard, American Legion Honor Guard) at funerals and civic functions.

Section 7. No person shall bring an animal onto the grounds of the cemeteries. However, assistance animals for the disabled are allowed.

Section 8. No advertising of any form will be allowed.

Section 9. Trucks may not be operated within the cemeteries without the express permission of the Superintendent.

Section 10. No person shall consume alcoholic or non-alcoholic beverages, excepting water, or consume any food upon the grounds of the cemeteries.

Section 11. Unnecessary noise in the cemeteries is prohibited.

---

It is the intent of the Board of Trustees to maintain Evergreen Cemetery and Memorial Gardens as quiet, beautiful resting places for the deceased; where well kept turf and a variety of trees and shrubbery will give a sense of repose. To this end, the Association has adopted the foregoing rules and regulations to secure peace and order within the cemeteries, to protect the interest of the lot and grave owners and to preserve the beauty of the grounds. All persons are requested to obey the rules and to report infractions or complaints to the Secretary or Superintendent.

---

## **REGULATIONS**

Section 1. Until all charges due the Association have been paid, no lot owner shall be permitted to erect a monument or marker upon his or her lot.

Section 2. The Association will not be responsible for any mistake occurring from the want of precise and proper instructions as to the particular space or location where the interment is desired.

Section 3. No money shall be paid to any workman or attendant as a fee or tip on the grounds.

Section 4. The Association will not be liable for any vases, containers, urns and the like that may become misplaced, broken or stolen.

Section 5. Diseased or dead trees or shrubs within Evergreen and Memorial Gardens Cemeteries may be removed by the Association at its expense. A healthy tree may be removed only if it prevents the use of a grave for a traditional burial. A healthy shrub will be removed by the Association at the lot owner's request and expense. Determination of fees and payment in all instances shall be made prior to doing the work.

Section 6. The scattering of ashes anywhere within Evergreen and Memorial Gardens Cemeteries is prohibited.

---

## **RULES TO BE OBSERVED WITHIN THE CEMETERIES**

Section 1. The motor vehicle gates to Evergreen Cemetery will be open from 8:00 a.m. to 5:00 p.m. Monday through Friday and closed on Saturdays and Sundays and Holidays, excepting Memorial Day as noted in Section 2, and from November 1st to April 1st (except for funerals). The 3<sup>rd</sup> Avenue gate and the pedestrian gates are open at all times. The gates at Memorial Gardens are open 24/7 year round.

Section 2. On Memorial Day only pedestrians will be admitted to the cemeteries except motor vehicles utilized as part of the Memorial Day Parade or as part of the services at the cemeteries.

Section 3. Motor vehicles may be driven within the cemeteries subject to these conditions:

- a. The speed of same shall not exceed 15 miles per hour.

Section 3. As part of the Perpetual Care, the Association shall have the right to remove any tree or shrub upon any lot which has or shall become by reason of age or other cause unsightly or detrimental to the lot upon which it is situated or any adjoining lot or avenue or which interferes with the ability to provide burial services.

Section 4. Markers that have settled into the ground and have become overgrown will be raised by cemetery staff upon request as time permits.

---

## **INTERMENTS and DISINTERMENTS**

Section 1. All interments and disinterments shall be made only by employees of the Association. Before any grave is opened there shall be paid to said Association for opening said grave the regular fee, also all indebtedness, if any. Arrangements must be made at least three business days in advance.

Section 2. In the event instructions for the opening of a grave are indefinite or, for any reason, the grave cannot be opened in the location specified, the Superintendent may order it opened at such location as he deems best under the circumstances.

Section 3. Lot owners desiring graves opened or other work done will be required to give satisfactory evidence of ownership. All orders as to location of graves or work to be done must be given by the owner.

Section 4. The Board of Trustees reserves the right to open all graves by workmen in its employ and to do all filling and sodding or other work upon lots or single graves.

Section 5. All graves for traditional burials of adults shall be not less than five feet deep, and for children not less than four feet deep.

Section 6. A traditional grave can have one traditional or cremation burial, and up to two additional cremation burials subject to spacing and depth requirements and with the approval of the Superintendent. A cremation section lot in Evergreen Cemetery can have up to two cremation burials.

Section 7. No interment of any body other than a human being will be permitted in the Cemeteries.

Section 8. In accordance with Minnesota Statutes, Section 306.29, no interment of any body, other than that of an immediate relative or heir of any lot owner shall be made in any lot, except by consent of the Board of

Trustees. In addition, the Cemetery Association requires that the consent must be requested by the lot owner by a written statement to the Trustees stating the reason for such burial and what remuneration, if any, has been promised or received for the privilege of so burying.

Section 9. As it takes more time and labor to inter and disinter during the winter months, an extra charge is made for such work. The Trustees have deemed winter to be from November 1<sup>st</sup> to March 31<sup>st</sup> or such later date when the ground has thawed.

Section 10. No interments will be permitted on Memorial Day, July 4th, Thanksgiving, Christmas or New Year's Day, except in the case of contagious diseases, in which cases the laws of the State Board of Health will be complied with.

Section 11. Interments commencing outside of normal hours (which are 9:00 AM to 4:30 PM Monday – Friday) will be accommodated only if cemetery staff are available, and a fee will be charged. Any weekend interment must commence by 3:00 PM.

Section 12. The Association shall not be liable for damage to caskets and urns during disinterment.

Section 13. The cremated body of an adult is not allowed in a lot platted for babies.

Section 14. The burial of commingled cremated bodies of two people in a single urn is allowed in an unused grave. The cremation burial opening and closing fee for the 2<sup>nd</sup> person will not be charged, but the fee for a 2<sup>nd</sup> burial on a grave still applies.

Section 15. A traditional burial requires the use of a grave liner or vault in order to minimize settling of the ground over the course of time.

Section 16. An in-ground burial of a cremated body requires the use of a separate urn vault or receptacle of a type approved by the Association. The interment should be at a depth allowing at least 12 inches of dirt from the top of the vault or receptacle to the overlaying sod. Any exceptions must be approved by the Superintendent.

---

## **SINGLE GRAVES**

Section 1. In case of the purchase of a lot and the removal later of a body thereto from a single grave, the usual price of disinterment and

within 30 days. If the owner does not do so, the Superintendent shall dispose of same in a manner as determined by the Board of Trustees.

Section 2. Perpetual Care does not include watering and maintenance of plants in urns and containers. This is the responsibility of the lot owner. If plants in urns and/or containers are not watered and maintained for a period of 30 days, the Secretary shall advise the owner to remove the urn and/or container because of lack of maintenance and if the owner does not remove same, the Superintendent shall dispose of same in a manner as determined by the Board of Trustees.

---

## **FUNERALS**

Section 1. All funerals within the cemetery will be under the charge and control of the Superintendent or his assistants. Automobile drivers employed at funerals must always keep to the right of roadways in the Cemeteries, and must remain with their respective cars during the continuance of the funeral services, and must conduct themselves in a manner becoming the place and occasion, and be subject to the direction and control of the Superintendent and his assistants.

Section 2. No burial will be permitted in any lot in the Cemeteries until such laws and ordinances, regarding burials, as may be in force in the State of Minnesota and City of Brainerd, have been complied with and until the burial fees have been paid.

---

## **COLUMBARIUM NICHES**

Section 1. Opening and closing of niches and access to the contents thereof will be done only by employees of the Association.

Section 2. Cremated remains of up to two people are allowed per niche as specified by the burial option selected in the Purchase Agreement. Commingling (mixing of ashes) of a cremated body with a cremated body previously placed in a niche will not be permitted.

Section 3. Engraving of niche fronts will be done only by a company designated by the Association and upon payment of the appropriate fee.

Section 4. No symbols, emblems or any other attachments are permitted on the niche fronts except for a Government approved military medallion. Only cemetery staff may affix such adornments. Unauthorized adornments will be removed and discarded.

for marker placement and subject to the rules for subsequent burials. Information about the deceased must be registered in the Association Office and a non-refundable fee paid in order to record the memorial marker as being for someone who is not buried here.

Section 15. The total number of markers, including veterans markers, allowed on a traditional gravesite shall not exceed three. Placement of a second or third marker must be approved by the Superintendent subject to any requirements for setback and spacing from any monument, markers, trees, etc.

Section 16. Concrete borders around markers are allowed and encouraged to minimize the settling and subsequent sod overgrowth that may occur. On-site concrete border work is to be done only by cemetery staff. Markers with pre-installed concrete borders will not be accepted without prior approval by cemetery staff and will be subject to additional charges.

---

## **FOUNDATIONS**

Section 1. All foundation and underground work must be under the direction and supervision of the Superintendent of the Association. The mortar used in foundations shall be of good Portland cement, one part of cement and two of clean sand, and no heavy stone work shall be set until the foundation shall have had time to thoroughly harden.

Section 2. Foundations for monuments and other stone work shall be finished true and level, and level with the ground in the lot, and shall be full size of base of monument and sufficiently true to allow every part of the base to be in contact with the foundation. But the Cemetery management reserves the right to have installed a larger foundation when in its estimation the weight of the structure requires it.

Section 3. No foundations will be installed (nor monuments erected) during the period one week before Memorial Day.

---

## **PLANT URNS and CONTAINERS**

Section 1. Any urns or containers or stands that are not utilized by the planting of flowers and/or decorative greenery by July 1st in any year will be removed by the Superintendent and held for 30 days. The lot owner, if capable of ascertainment from the Association's records, shall be notified in writing to take possession of the urn or container or stand

interment will be charged, and the amount paid for the ground of a single grave will be allowed on the purchase price of the lot.

Section 2. When the interment expense of destitute parties is beyond the means of survivors, the adjustment of such expenses is left to the discretion of the Board of Trustees.

---

## **GRAVE DECORATIONS**

Section 1. Fences or hedges are not allowed on or around any lot.

Section 2. Uneven surfaces such as mounds and berms or objects such as bricks, rocks, etc. are not permitted.

Section 3. Christmas wreaths are allowed starting November 15<sup>th</sup> and must be removed by April 1<sup>st</sup>, after which they will be discarded.

Section 4. Live flowers and small decorative live greenery (not to include shrubs, arborvitae, etc.) may be planted in the ground immediately adjacent to a monument or marker, preferably to the right or left.

Section 5. Live or artificial flowers and decorative greenery kept in a large, permanent flowerpot on the ground, in an urn on a stand, or hanging from a standard shepherd's hook will be permitted all year. They must be immediately adjacent to the left or right side of a monument if one exists, or in the center of a lot in line with other monuments if there is no monument, or adjacent to a marker. Plant containers must be maintained in an attractive manner and used for their intended purpose or they will be subject to removal and disposal.

Section 6. Artificial flowers and decorative greenery, and objects such as toys or personal belongings may be temporarily placed on a gravesite during the period commencing the day before Mother's Day (2nd Sunday in May) through the day after Father's Day (3rd Sunday in June). Items left on a gravesite outside this period may be removed and discarded by cemetery staff. Glass items are not allowed.

Section 7. Live and artificial flowers and greenery must be maintained in an attractive manner or they will be subject to removal.

Section 8. One flag-holder or official metallic tablet of the Grand Army of the Republic, or other similar organizations whose membership is limited to those who served in the military forces of the U.S.A., will be permitted upon a grave. Otherwise, a single non-military insignia (such as for the D.A.R.) in the form of a flat metallic tablet no greater than 8 x 8 inches is

permitted upon a grave. It must be permanently and securely attached to an upright monument, embedded in a lawn-level marker, or embedded within a concrete foundation (identical to the concrete base for a vase) that is intended for use only as a secure place of attachment and placed at lawn-level so as to not interfere with mowing. All such work is to be performed only by cemetery staff. Fees will be charged as appropriate.

Section 9. One small U.S. flag in good condition no larger than 8 x 12 inches with a maximum 24 inch staff is permitted per gravesite. Faded or tattered flags will be removed.

Section 10. Solar lights may be placed in the ground only if immediately adjacent to an above-ground monument (not adjacent to a lawn-level marker). They may also be placed off the ground in an urn or flowerpot. To preserve the dignity of the cemetery, flashing or otherwise active lights are discouraged. Objectionable lights will be removed.

Section 11. To preserve the aesthetics of the cemetery, no items of any kind may be attached to any tree or bush.

---

## **MONUMENTS and GRAVE MARKERS**

Section 1. Mausoleums, above-ground vaults and tombs are not permitted in Memorial Gardens or Evergreen Cemetery.

Section 2. At Memorial Gardens, upright monuments, subject to the conditions set forth within these Rules and Regulations, may be erected only within the Garden of Paradise. Only grave markers are allowed in the Garden of Devotion and the Garden of the Christus,

Section 3. Monument companies may erect monuments in the Cemeteries subject to the supervision of the Superintendent and in compliance with the Rules of the Association herein contained and fees will be charged, as appropriate.

Section 4. Except as prohibited at Memorial Gardens, the proprietor of each lot may erect any proper monument thereon, provided that design of the proposed monument be approved by the Superintendent. Only one monument on each four-grave traditional lot or larger will be allowed. Lawn-level markers, only, will be allowed on one, two, or three grave lots

Section 5. Monuments or markers constructed of any material other than stone or real bronze will not be allowed

Section 6. To insure sufficient support, monuments must have foundations built of solid masonry, with a depth and size deemed proper by the Superintendent, who shall have the power to stop all work not done in conformity to these rules. See FOUNDATIONS section, below.

Section 7. Monuments shall be set on the central longitudinal line of a lot, except on lots of irregular shape, in which case the Superintendent shall determine the location. Monuments will be allowed only on one-half or larger lots and the base of which must not exceed more than six percent of the lot area.

Section 8. A monument will be allowed on a two-side-by-side-grave lot subject to several conditions (full details are available in the office). The owners of all four graves in the 2x2 grave configuration of a four-grave lot must execute a written agreement to share a monument that is centered within that lot and file the agreement with the Association.

Section 9. Irrespective of any regulations to the contrary, the design, height and width of all upright monuments must be approved by the Superintendent prior to installation; it being understood that the height of an upright monument shall not exceed five (5) feet.

Section 10. No monumental work or other structural material shall be brought into the Cemetery on Saturdays or Sundays, or the day before Memorial Day or on Memorial Day, and no work shall be commenced on Saturday which cannot be finished and the dirt and debris entirely removed before the hour of quitting work.

Section 11. No monument or marker shall be removed from the Cemetery unless the written order of the lot owner be presented at the office and permission be granted by the Association.

Section 12. All grave markers are to be installed (or removed) only by employees of the Association and must be set with their tops level with the surface of the ground (lawn-level).

Section 13. The maximum dimensions for the various type of markers are as follows: single marker – 24" x 12"; double marker – 30" x 14"; double marker spanning two side by side traditional graves – 48" x 14"; a second such double marker for a pair of second burials (or as a memorial) can be no larger than 40" x 12". A double marker on a cremation gravesite is limited to 30" x 14". A lawn-level marker or any base upon which a marker is mounted must be at least 4 inches thick

Section 14. A memorial marker for someone whose remains are not interred in the cemetery may be placed on a gravesite subject to the fees
