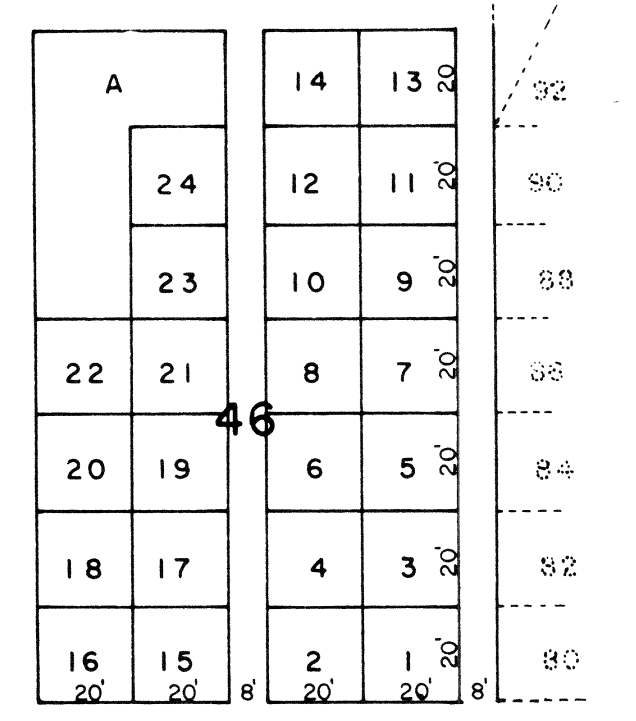
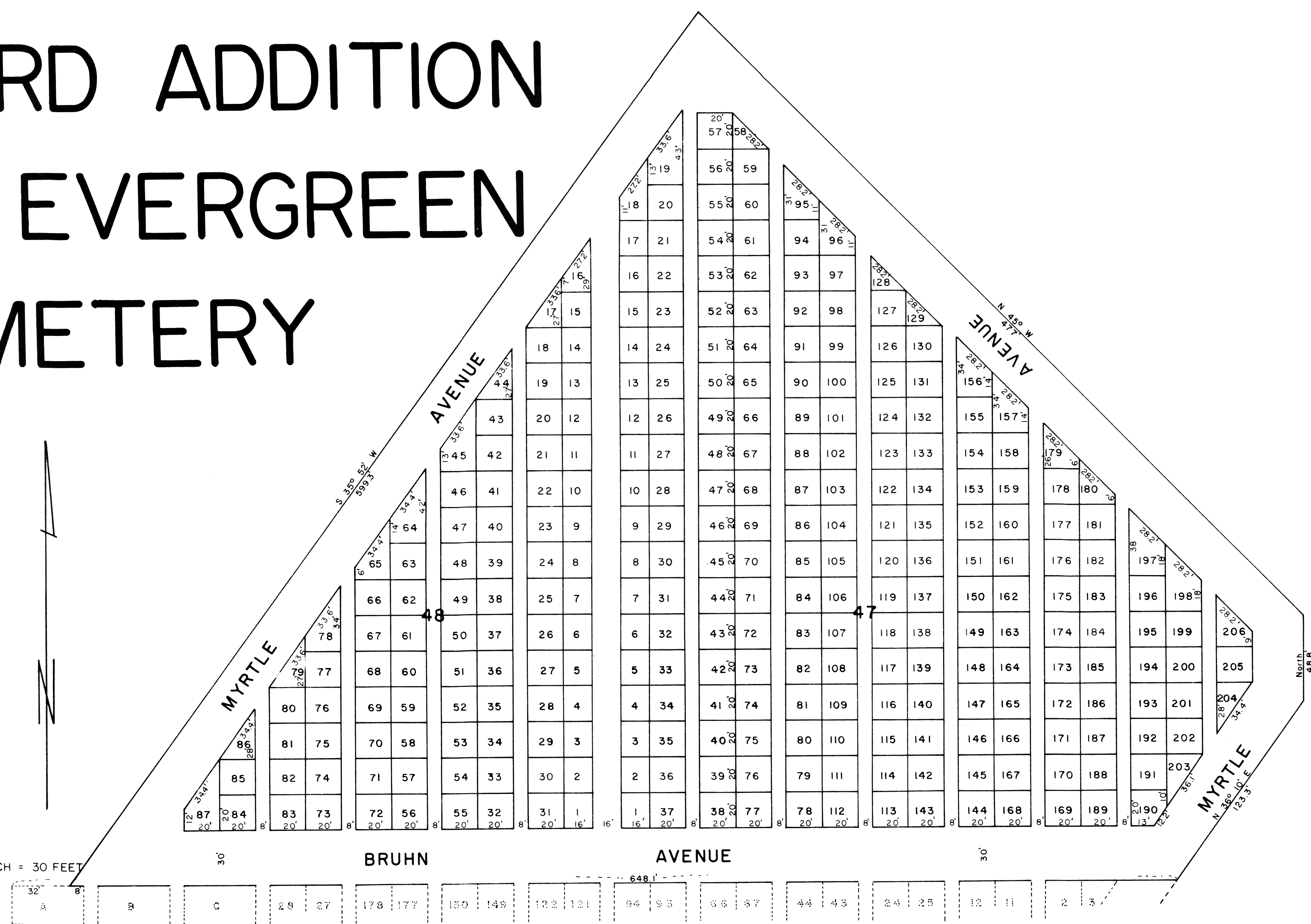


# THIRD ADDITION TO EVERGREEN CEMETERY

KNOW ALL MEN BY THESE PRESENTS: THAT EVERGREEN CEMETERY ASSOCIATION, A MINNESOTA CORPORATION, IS THE OWNER OF THAT PART OF THE WEST HALF OF THE NORTHWEST QUARTER (W $\frac{1}{2}$ -NW $\frac{1}{4}$ ) OF SECTION 15, TOWNSHIP 45 NORTH, RANGE 30 WEST DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF BLOCK 37, "SECOND ADDITION TO EVERGREEN CEMETERY"; THENCE NORTH 170 FEET ALONG THE WEST LINE OF BLOCK 45, SAID CEMETERY; THENCE WEST 96 FEET; THENCE SOUTH 170 FEET TO THE NORTHWEST CORNER OF BLOCK 35, SAID CEMETERY; THENCE EAST 96 FEET TO THE PLACE OF BEGINNING, AND THAT PART OF SAID W $\frac{1}{2}$ -NW $\frac{1}{4}$  DESCRIBED AS FOLLOWS: BEGINNING AT THE POINT ON THE NORTH LINE OF LOT A, BLOCK 45, "SECOND ADDITION TO EVERGREEN CEMETERY" WHICH IS 32 FEET EAST OF THE NORTHWEST CORNER OF SAID LOT A; THENCE EAST 616.1 FEET; THENCE NORTH 36 DEGREES 10 MINUTES EAST 123.3 FEET; THENCE NORTH 48.3 FEET; THENCE NORTH 45 DEGREES WEST 477 FEET; THENCE SOUTH 35 DEGREES 52 MINUTES WEST 599.3 FEET TO THE PLACE OF BEGINNING, AND BEING DESIROUS OF PLATTING SAID LAND INTO CEMETERY LOTS, HAS HAD THE SAME SURVEYED, AND THE ANNEXED PLAT THEREOF, MADE ACCORDING TO THE STATUTES IN SUCH CASES, MADE AND PROVIDED. THE NAME OF THIS PLAT SHALL BE "THIRD ADDITION TO EVERGREEN CEMETERY". THE AVENUES AND ALLEYS SHOWN HEREON ARE DEDICATED TO THE PUBLIC USE.
